Laurelwood PTA is a partnership comprised of parents, teachers, and the community. We work together to ensure that every student receives an exceptional educational experience.

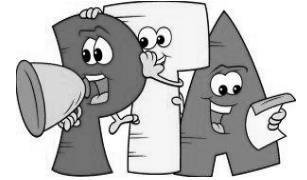

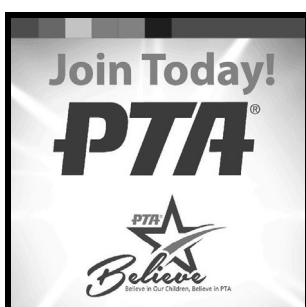
